

AN ORDINANCE OF THE BOARD OF
COMMISSIONERS OF THE COUNTY OF JENNINGS:

- (1) Adopting the Provisions of Chapter 138, Acts of 1957 as Amended by Chapters 29 and 308, Acts of 1959, Indiana General Assembly,
- (2) Fixing a Time for the Establishment of an Area Planning Department, and,
- (3) Providing for the appointment of a representative from the Town Council of the Town of Vernon, County Of Jennings, to the Area Planning Advisory Council.

WHEREAS, Jennings County, Indiana, desires to participate in the establishment of an Area Planning Department of Jennings County, Indiana, and

WHEREAS, expanding urbanization within the state has created many new problems involving streets and highways, transportation, drainage, water, land use, schools, and recreation, which are beyond the ability of a single city or county to solve, and

WHEREAS, local units of government should cooperate to improve the health, safety, convenience, and the welfare of their citizens and to plan for the future development of their communities and to the end that highway systems be more carefully planned, that old and new communities grow only with adequate street, utility, health, educational and recreational facilities, and

WHEREAS, the needs of agriculture, industry and business should be recognized in future growth, and

WHEREAS, residential areas should provide healthy surroundings for family life, and

WHEREAS, the growth of the community should be commensurate with and promotive of the efficient and economical use of public funds, and

WHEREAS, Chapter 138, Acts of 1957, as amended by Chapter 29 and 308, Acts of 1959, Indiana General Assembly, encourages and

authorizes cities, towns, and counties to cooperatively establish single and unified planning and zoning agencies to deal with these problems on a county-wide basis, and

WHEREAS, The City of North Vernon and the Town of Vernon have heretofore expressed their desire to participate in the establishment of an Area Planning Department in Jennings County, Indiana, and

WHEREAS, it is in the best interests of the Town of Vernon, Indiana, to do so,

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Vernon, to-wit:

SECTION 1. That the Town of Vernon, Indiana, and the Town Council of the Town of Vernon, do hereby adopt the provisions of Chapter 138, Acts of 1957, as amended by Chapters 29 and 308, Acts of 1959, Indiana General Assembly.

SECTION 2. That on the 1st day of January, 1966, is hereby fixed for the establishment of an Area Planning Department, pursuant to the provisions of Chapter 138, Acts of 1957, as amended by Chapters 29 and 308, Acts of 1959, Indiana General Assembly.

SECTION 3. That James De Tray of the Town Council of the Town of Vernon, Jennings County, Indiana, is hereby selected and appointed as a representative of the Town of Vernon, Indiana, to the Area Planning Advisory Council, pursuant to the provisions of Chapter 138, Acts of 1957, as amended by Chapters 29 and 308, Acts of 1959, Indiana General Assembly.

SECTION 4. That a copy of this ORDINANCE Be certified to every legislative body within Jennings County, Indiana.

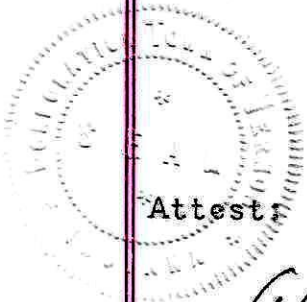
